

PRICE BULLETIN TERMS AND CONDITIONS

Prices are based on quantities computed on 100% tank tables or mutually acceptable automatic measuring equipment corrected for temperature to 60 degrees Fahrenheit with full deduction for basic sediment and water.

All crude oil and/or condensate purchased shall be of merchantable quality, unaltered and uncontaminated by any foreign substances or chemicals not normally associated with such oil, and which is suitable for normal refinery processing. Applicable measurements, deductions, and adjustments for temperatures, BS&W, and gravity will be made in accordance with the rules and regulations of Coffeyville Resources Crude Transportation, LLC, and any applicable regulatory body. All base prices are subject to change without notice and subject to the Terms and Conditions of the applicable Division Orders. Coffeyville Resources Crude Transportation, LLC reserves the right to refuse crude oil or condensate having a Reid Pressure of 10 PSI or above.

If applicable law or government regulations require adjustments to Coffeyville Resources Refining & Marketing, LLC prices or effective dates, Coffeyville Resources Refining & Marketing, LLC reserves the right to amend this posting and recover any excess payment by withholding payments from future settlements or by separate invoicing.

GRAVITY ADJUSTMENTS SCALE TO DEDUCT FROM POSTED PRICES

Effective March 1, 2007

- 1. Less \$0.015 per barrel for each 0.1 degree API below 40.0; less \$0.015 per barrel for each 0.1 degree API above 44.9.
- 2. No deductions per barrel for each full degree API below 40.0 to 35.0; then less \$0.01 per barrel for each 0.1 degree API below 35.0 to 30.0; then less \$0.015 per barrel for each 0.1 degree API below 30.0; less \$0.015 per barrel for each 0.1 degree above 44.9.
- 3. Less \$0.02 per barrel for each full degree API below 40.9; less \$0.015 per barrel for each 0.1 degree API above 44.9.
- 4. Less \$0.015 per barrel for each 0.1 degree API below 40.0.

Effective May 1, 2015

5. Less \$0.03 per barrel for each 0.1 degree API above 47.0; then less \$0.05 per barrel for each 0.1 degree API above 50.0.

Effective June 1, 2011, the following price deductions will be applied to crude oil delivered to CVR's Humboldt facility only: BS&W percentages of 2.1 - 2.9 less \$1.50 per barrel; 3.0 - 3.9 less \$2.25 per barrel; 4.0 - 4.9 less \$3.00 per barrel; and 5.0 -5.9 less \$3.75 per barrel.
